The digit "5" will allow you to test all of the keys on your touchtone pad, to be sure they are all working correctly. In addition, each member receives two autodial slots (speed dialing) of their choice. (Check with George, W8FWG and give him your telephone number and the two-digit slot you would like to have. (I have a record of all subscribers, and their speed call numbers.)
